



***LOVELL PARK PAVILION - 362 E. Hahn's Peak Ave.**

The rental of the pavilion will give access to sand volleyball court, horseshoe pits, and BBQ grill that you can use unless we are under a **FIRE BAN**. (Renters would need to bring their own sports equipment, or charcoal for grill). Water and electric is available. If your event is scheduled after 3pm, renter will need to pick up a bathroom key from the Parks office.

***CIVIC CENTER PAVILIONS - 61 E. Civic Center Plaza.**

The rental of any pavilion does not give exclusive access to amenities at the park. Civic Center Park is a public park for everyone to use. **Splash Park runs Friday, Saturday & Sunday; 11am - 3:30pm**

NORTH COLUMBINE & SOUTH SAGE PAVILIONS for up to 25 people

***CATTAIL CROSSING PAVILIONS - 253 McCulloch Blvd. (NO ALCOHOL allowed at Cattail Pond)**

Renters might need to wipe down benches since wildlife roams the area. When your event is finished, all trash must be disposed of so the wildlife does not get into it. (Kids ages 4-15 and adults with disabilities can fish without a license; 4 fish max). Dogs at pond events must be leashed at all times.

LARGE PAVILION, for up to 25 people **Rental Rate: \$50 Damage Deposit: \$100**
TWO SMALLER PAVILIONS are first come first serve.



ON ANY FACILITY RENTALS:

NO DRUGS or BOUNCE HOUSES are allowed at ANY Pueblo West Parks facility.

Bathrooms are open 7am to 3pm

Reserved signs are posted onsite for all paying reservations.

Beer Permits are available for \$40 for **KEG or CAN** only! **NO GLASS, NO BOTTLECAPS** or you forfeit your damage deposit.

It is the renters responsibility to clean up the area after use. All garbage must be hauled to dumpsters provided for you, or your damage deposit may be forfeited.

Dogs are welcome but it is a Pueblo County ordinance that they be leashed at all times.

Cancellations – must be done **10 business days before** reservation date for full refund, call the Parks office.

Damage deposits are issued back the next working business day.
